2. Please submit the proper team fee of \$100 (or \$80 if this is your 2nd or subsequent team) with this application. These fees are for teams wanting website delivery of all data with no mailed package.
For teams wanting the traditional mail delivery, add \$20 to the above fees.
3. Fill out the draft list below. The total of all your bids for the 17 sets of players should equal 100. There is a minimum bid of 1 for each set, except that you are not required to bid on set Q, the open round.
WHOLE NUMBER BIDS ONLY. Rate the players in each set from 1 (highest) to 12 (lowest) according to how much you would like to have that player on your team. All players should be rated. See Rulebook for details.
